

CHANGE OF DETAILS OR SIGNIFICANT AMENDMENTS TO YOUR FOOD BUSINESS

sections 51 and 81 Food Act 2014

This form is to notify us of any changes in details or significant amendments to your food business, for example a change of premises, trading name, or the scope of your operation.

If you are a new operator of a business, then a new registration application is required. Use the Application for Registration form for that. It is available on our website.

There is a fee for a significant amendment of a Food Control Plan or National Programme:

- Refer to our Health Registration Fees list: huttcity.govt.nz/food-fee

Note: Change of contact details eg email, postal address where no new certificate is required: Free of charge.

If you are changing the scope of your operation by making or selling different types of food, this may result in your operation being a different level of National Programme or requiring a Food Control Plan. You should check the 'Where do I fit?' tool available on the Ministry for Primary Industries (MPI) website mpi.govt.nz. This may mean you will have to re-register.

Examples of Significant Amendments:

- Changing location or adding new premises to a multi-site registration
- Changes to scope of operation that are outside your current scope on certificate
- Major alterations to facilities or equipment
- Changing the business structure where this impacts on the overall operation.

Examples of Changes in Details:

- Minor changes to processes that are still covered in the plan eg cooking chicken
- Change of verification agency
- Change in your contact details eg email, phone, or trading name
- Minor changes to products, processes or plan

Once you have submitted your notification:

If you are making a significant amendment or need a new certificate it will be sent out to you in the post.

If you have notified us of a significant amendment, this may require verification within six weeks.

Collection of Information:

Collection of Personal Information. Pursuant to Principle 3 of the Privacy Act 1993, we advise that:

- This information is being collected for the purpose of registering under the Food Act 2014; and
- The recipient of this information, which is the agency that will collect and hold the information, is Hutt City Council, 30 Laings Road, Private Bag 31912, Lower Hutt 5040
- Some of the information collected will be displayed on a public register; and
- The collection of information is authorised under section 51 & 81 of the Food Act 2014, which ever applies. The provision of this information is necessary in order to process an application for registration under section 53; and
- The supply of this information is voluntary; but
- Failure to provide the requested information is likely to result in a return of this application form to the applicant, and may ultimately result in a refusal to register, in accordance with section 54 and 57 or 84 and 87 of the Food Act 2014, and
- Under Principles 6 and 7 of the Privacy Act 1993, you have the right of access to, and correction of, any personal information that you have provided.

Collection of Official Information:

- All information provided to the Hutt City Council is official information and may be subject to a request made under the Official Information Act 1982. If a request is made under that Act for information you have provided in this application, the Hutt City Council must consider any such request in accordance with its obligations under the Official Information Act 1982 and any other applicable legislation.
